MATT CLOOS - MSA PROFESSIONAL SERVICES, INC.

Matt Cloos came before the Board to introduce himself and explain the engineering work that his company, MSA Professional Services, Inc could provide for the Bellevue Municipal Utilities. Cloos then asked the Board to consider MSA for any future engineering work.

FELDERMAN PARK LIGHTING

City Administrator Loras Herrig presented the request for the Board to finance lighting at Felderman Park as various individuals have offered to make lighting donations. After a detailed discussion, Walsh moved with a second by Zeimet not to provide lighting for Felderman Park. However, the Board would be open to further discussions on lighting as Felderman Park becomes further developed. Motion carried unanimously.

RADIUM TREATMENT FACILITY

Ryan Kloft appeared before the Board to ask questions about the Radium Treatment Facility's proposed location off Park Street, adjacent to Kloft's residence. Kloft expressed his concerns regarding the future of his property's value and the traffic levels to the facility. The Board would like to invite both Kloft and City Engineer Marc Ruden to the next Utility Board meeting to further review the project and to address these concerns.

WATER LINE TO NORTH RIVERVIEW PARK

Electric Superintendent Bob Ploessl reviewed a proposed water line installation plan to the north end of Riverview Park. The plan also includes installing two drinking fountains. After a detailed discussion, Zeimet moved with a second by Walsh to for the Utilities to provide the water line extension at cost of approximately \$5000.00 and to also purchase one of the drinking fountains at a cost of approximately \$4000.00. Motion carried unanimously.

FYE 2018 BUDGET

Ploessl and Herrig presented the FYE 2018 Budget request to the Board. After reviewing the budget, Walsh moved with a second by Nudd to approve the FYE 2018 Budget. Motion carried unanimously.
